

COMMUNITY DEVELOPMENT BLOCK GRANT FOR DISASTER RECOVERY HOMEBUYER ASSISTANCE PROGRAM PUERTO RICO DEPARTMENT OF HOUSING REDEVELOPMENT INCENTIVE CERTIFICATION FORM

The Puerto Rico Housing Finance Authority (PRHFA), as the designated Subrecipient of the Homebuyer Assistance Program (HBA or the "Program"), will administer CDBG-DR funding to support first-time homebuyers with the purchase of an existing property. Qualified Applicant(s) may be eligible to receive financial assistance in the form of a Grant to be used towards a down payment on a new or existing home, including eligible prepaids and/or closing costs. Assistance amount will be limited to the amount necessary to achieve homeownership. Therefore, the purpose of this form is to submit the property information, for PRDOH to review property's location and certify whether the property is located within a designated urban center and certify it as one eligible for the redevelopment incentive.

The Program will provide an additional redevelopment incentive of up to five thousand dollars (\$5,000.00) to eligible households who elect a home in a designated urban center certified by the Puerto Rico Department of Housing (PRDOH) as stated in the Program Guidelines¹. The PRDOH has defined the urban centers for each municipality in Puerto Rico. The maps will be published and made available at www.cdbg-dr.pr.gov.
